#### Introduction

The Council on American-Islamic Relations (CAIR), the nation's largest Muslim civil rights and advocacy organization, has compiled a unique resource, our CAIR 2022 Midterm Election Congressional Scorecard, to help educate Muslim community members and allies as they plan to vote in this year's midterm November elections.

CAIR's congressional scorecard reflects the voting performance of many representatives from the U.S. Congress that are up for re-election in the 2022 midterm election. The votes of each legislator have been rated positively with green font (example: Y, N, Cosponsor) or negatively with red font (example: Y, N, Cosponsor) depending on how closely their votes on relevant legislation corresponded with civil rights and social justice priorities identified by CAIR. The criteria selected for each topic is rooted in legislation introduced and voted upon in 117<sup>th</sup> U.S Congress (2021-2022).

Members of congress who do not co-sponsor legislation or sign on to letters endorsed by CAIR will not be negatively rated. That is because not every Congressional office may have had the same opportunity to co-sponsor legislation or letters circulated that are supported by CAIR.

As the amount of legislation introduced in Congress is rather expansive - elected officials highlighted in this scorecard should not be judged by these criteria alone. This scorecard is intended to provide a general profile that we hope will assist voters in better understanding the attitudes of elected officials towards these key issues. A member of Congress' lack of cosponsorship or support for a congressional letter does not necessarily indicate their position on a given issue. CAIR makes no claims as to the favorability of one candidate being elected over another. Therefore, we encourage readers of this guide to further research the actions of their local representatives before supporting any candidate.

The 2022 election cycle once again presents the American Muslim community with an important opportunity to increase its political capacity and presence. With large concentrations of Muslim voters in key swing states such as Arizona, Florida, Georgia, Michigan, Minnesota, Nevada, North Carolina, Ohio, Pennsylvania, Virginia, and across the nation, the American Muslim population has the potential to be influential in determining which political party will control the U.S. House of Representatives, the U.S. Senate, and the results of other local, county, and state elections.

As a nonpartisan organization, CAIR can encourage American Muslims to participate in national and state elections, conduct voter registration and get-out-the-vote drives, provide training programs, issue briefings, organize candidate forums, volunteer in campaigns, and lead get-out-the-vote drives. Nonprofits cannot engage in political activities that support one candidate or party over another, but we are committed to making our community's voice and vote heard. # CAIR 2022 MIDTERM ELECTION CONGRESSIONAL SCORECARD Legislation, Votes and Letters of Interest to CAIR U.S. House of Representatives and U.S. Senate

### **George Floyd Justice in Policing Act of 2021**

**H.R.1280:** To hold law enforcement accountable for misconduct in court, improve transparency through data collection, and reform police training and policies.

**CAIR Position:** Support.

**Status:** Passed in the U.S. House with a vote of 220-212 and was referred to the U.S. Senate Committee on Judiciary.

**About:** Introduced in February 2021 by Representative Karen Bass (D-CA), the bill aims to address a wide range of policies and issues regarding policing practices and law enforcement accountability. It increases accountability for law enforcement misconduct, restricts the use of certain policing practices, enhances transparency and data collection, and establishes best practices and training requirements. The bill enhances existing enforcement mechanisms to remedy violations by law enforcement and establishes a framework to prevent and remedy racial profiling by law enforcement at the federal, state, and local levels.

The bill also limits the unnecessary use of force and creates a national registry to compile data on complaints and records of police misconduct along with establishing new reporting requirements and recommending that the Department of Justice create uniform accreditation standards for law enforcement agencies and requires law enforcement officers to complete training on racial profiling, implicit bias, and the duty to intervene when another officer uses excessive force.

### **Stop Militarizing Law Enforcement Act**

**H.R.1694:** To amend title 10, United States Code, to direct the Secretary of Defense to make certain limitations on the transfer of personal property to Federal and State agencies, and for other purposes.

**CAIR Position:** Support.

**Status:** Introduced to the House in March 2021 and was referred to the U.S. House Committee on Armed Services.

**About:** Introduced in March 2021 by Representative Henry Johnson Jr. (D-GA), the act restricts the Department of Defense from transferring certain surplus military property to federal, state, or local law enforcement agencies. These include

controlled firearms, ammunition, grenade launchers, explosives, certain vehicles or trucks, armored or weaponized drones, certain controlled aircraft, silencers, or long-range acoustic devices. The Department can waive this limitation if it is determined that the transfer is necessary for disaster or rescue purposes or for another purpose where life and public safety are at risk.

This bill also eliminates the requirement for the Department of Defense to give preference to transfers of property that will be used in counter-drug, counterterrorism, disaster-related emergency preparedness, or border security activities.

# National Origin-Based Antidiscrimination for Nonimmigrants Act (NO BAN Act)

**H.R.1333 / S.1891:** To transfer and limit Executive Branch authority to suspend or restrict the entry of a class of aliens.

**CAIR Position:** Support.

**STATUS:** H.R.1333 passed in the House by a vote of 218-208. The act was received in the Senate April 2021 and referred to the Senate Committee on the Judiciary. S.1891 was introduced in the Senate in May 2021 and referred to the Judiciary Committee.

About: Championed by Representative Judy Chu (D-CA) and Senator Chris Coons (D-DE), this bill prohibits religious discrimination in various immigration-related decisions in response to the former Trump administration's Islamophobic and discriminatory Muslim and African bans. As similarly worded companion bills in the U.S. House and Senate introduced in early 2021, these acts aim to impose limitations on the office of the President's authority to suspend or restrict aliens from entering the United States based on religion.

Only if there is a specific and credible threat to U.S. interests - such as security or public safety - can the President temporarily restrict entry into the country. Individuals or entities present in the U.S. lawfully harmed by any such restrictions may sue in federal court. These restrictions would also be issued only when there is a compelling government interest and using the narrowest means possible under this bill as well.

### **Access to Counsel Act**

**H.R.1573/S.1912:** To clarify the rights of certain persons who are held or detained at a port of entry or at any facility overseen by U.S. Customs and Border Protection.

**CAIR Position:** Support.

**Status:** H.R.1573 passed in the House by 217-207 in April 2021. The bill was referred to the Senate Committee on the Judiciary. S.1912 was introduced in the Senate in May 2021 and referred to the Committee on the Judiciary.

**About:** Introduced respectively by Representative Pramila Jayapal (D-WA) and Senator Alex Padilla (D-CA), this act would guarantee CBP and ICE provide persons detained for more than an hour in secondary screening access to their private legal counsel, including non-citizens and unaccompanied children, who may be detained at the U.S. border or ports-of-entry for long periods of time.

The counsel and related party shall be allowed to advocate on behalf of the covered individual, including by providing evidence and information to the examining immigration officer.

### **House Resolution Prohibiting Certain Defense Sales to Israel**

**H.J.Res.49:** U.S. House Resolution Providing for Congressional Disapproval of the Proposed direct Commercial Sale to Israel of certain Weaponry and Munitions.

**CAIR Position:** Support.

**Status:** H.J.Res.49 was introduced in the House in May 2021 and referred to the U.S. House Committee on Foreign Affairs.

**About:** This joint House and Senate resolution introduced by Representative Alexandria Ocasio-Cortez (D-NY) and Senator Bernie Sanders (I-VT) prohibits the issuance of an export license for specified defense articles, defense services, and technical data to support weapons integration, flight test, and hardware delivery of Joint Direct Attack Munition variants and Small Diameter Bomb Increment I variants for end-use by the Ministry of Defense for Israel. This joint resolution was introduced in response to Israel's longstanding human rights violations and abuse of U.S. provided weapons to oppress, injure or kill Palestinian civilians.

**Note:** Senator Sanders' identical companion resolution, S.J.Res.19, has not yet received a co-sponsor and been referred to the Senate Committee on Foreign Relations. Due to this Senate resolution not receiving any co-sponsors, CAIR is not scoring the Senate version of the resolution.

# Repeal of 2002 Authorization for Use of Military Force (AUMF) in Iraq

H.R.256 / S.J.Res.10: To repeal the Authorization for Use of Military Force Against Iraq Resolution of 2002

**CAIR Position:** Support.

**Status:** H.R.256 passed in the House in June by 268-161 and was referred to the Senate Committee on Foreign Relations. Companion resolution S.J.Res.10 was also referred to the Senate Committee on Foreign Relations.

**About:** Championed by Representative Barbara Lee (D-CA) in the U.S. House and Senator Tim Kaine (D-VA) in the Senate, this bill repeals the Authority of Use of Military Force Against Iraq Resolution of 2002. The 2002 AUMF authorized the use of American armed forces against the Saddam Hussein regime. If the Senate votes to repeal it, the President's ability to order military actions in Iraq without congressional approval would come to an end. The separate 2001 AUMF, which authorizes attacks on those co connected with the September 11, 2001, terrorist attacks and gives the president even more sweeping powers, is not impacted by the repeal of the 2002 AUMF.

### **Keeping Our Promise Act (H.R.3548)**

**H.R.3548:** To authorize the issuance of visas and admission of certain aliens, and their derivatives, who were selected to apply for diversity immigrant visas but were unable to be issued such visas or be admitted to the United States as a result of certain Presidential Proclamations, and for other purposes.

**CAIR Position:** Support.

**Status:** Introduced in the U.S. House in May 2021 and referred to the House Committee of the Judiciary.

**About:** In response to the imminent expiration of thousands of individuals eligibility for Diversity visas, Representative Ritchie Torres (D-NY-15) proposed H.R.3548, which issues these visas to qualified individuals who were previously denied. The bill specifically applies to individuals denied diversity lottery visas because of the discriminatory and Islamophobic Muslim and African Ban executive orders issued by the Trump Administration in 2017, as well as those who were denied an interview or entry after receiving a visa as a result of COVID-19 travel restrictions. This bill additionally relaxes annual numerical limits on visa issuing under the provisions of this bill.

### **Uyghur Forced Labor Prevention Act**

**H.R.1155/ S.65:** Ensuring that goods made with forced labor in the Xinjiang Uyghur Autonomous Region of the People's Republic of China do not enter the United States market, and for other purposes.

**CAIR Position:** Support.

About: H.R.1155 was signed into law by President Biden in December 2021.

**About:** Introduced by Senator Marco Rubio (R-FL) with bipartisan support from Senator Jeff Merkely (D-OR), the bipartisan Uyghur Forced Labor Prevention Act (S.65/H.R.1155) prohibits the importation of goods made with forced labor in China's Uyghur Region by Uyghur Muslims and other Turkic ethnic minorities.

The Uyghur Forced Labor Prevention Act would create a "rebuttable presumption" that any goods made in the Xinjiang are made with forced labor and prohibited from entering the United States unless "clear and convincing" evidence is shown to the contrary.

The Chinese government is guilty of an ongoing campaign targeting Uyghur Muslims and other Turkic ethnic minorities with a campaign of genocide. Millions of Uyghurs have been detained in concentration camps in which beatings, torture and rape are the norm. Millions more are being used as slave labor on plantations and in Chinese factories.

### **Combating International Islamophobia Act**

**H.R.5665/S.3384:** To establish in the Department of State the Office to Monitor and Combat Islamophobia, and for other purposes.

**CAIR Position:** Support.

**Status:** H.R.5665 was passed by the House in December 2021 by 219-212. S.3384 was introduced the same day that its companion was adopted by the House. Both bills have been referred to the Senate Committee on Foreign Relations.

**About:** Introduced by Representatives Ilhan Omar (D-MN) and Jan Schakowsky (D-IL) in the House and Senators Corey Booker (D-NJ), Bernie Sanders (I-VT), and Ben Cardin (D-MD) in the Senate, the Combating International Islamophobia Act would establish a special envoy office at the U.S. State Department to monitor and combat international Islamophobia.

The act would compel the State Department to develop a more comprehensive approach to fighting the global increase of Islamophobia, increasing its capacity to monitor and confront state and non-state actors.

The two primary aims of the Combating International Islamophobia Act are:

Establishing an Office to Monitor and Combat Islamophobia at the State Department headed by a Special Envoy for Monitoring and Combating Islamophobia.

Amending the Foreign Assistance Act and International Religious Freedom Act to require annual reporting on Islamophobia in each foreign country and the steps taken by that country to combat it through educational programing and public awareness initiatives.

The United States currently monitors and combats religious persecution internationally. The Combating International Islamophobia Act would extend this mission to Islamophobia.

The act would also provide valuable information for understanding Islamophobia as a global phenomenon and give the U.S. a new tool to combat it.

While global Islamophobia, anti-Muslim state policies, and hate incidents have increased, for the past two decades the American Muslim community has consistently called for the creation of a special envoy position to monitor and combat this rising tide of hate – the Combating International Islamophobia Act would make this special envoy position a reality.

# U.S. House Resolution Condemning Human Rights Violations and Violations of International Religious Freedom in India

**H.Res.1196:** Condemning human rights violations and violations of international religious freedom in India, including those targeting Muslims, Christians, Sikhs, Dalits, Adivasis, and other religious and cultural minorities.

**CAIR Position:** Support.

**Status:** H.Res.1196 was introduced in the House in June 2022 and referred to the House Committee on Foreign Affairs.

**ABOUT:** Introduced by Representative Ilhan Omar (D-MN), it condemns human rights violations and violations of international religious freedom by India to religious and cultural minority groups including Muslims, Christians, Sikhs, Dalits, and Adivasis. This resolution additionally calls on the Secretary of State to officially designate India as a Country of Particular Concern under the International Religious Freedom Act.

A Country of Particular Concern (CPC) are countries designated by the U.S. government where those listed governments engage in or tolerates "particularly severe" violations of religious freedom.

The resolution's original co-sponsors include Representatives Rashida Tlaib (D-MI), James McGovern (D-MA), and Juan Vargas (D-CA).

### Renewing Immigration Provisions of the Immigration Act of 1929

**H.R.8433:** To amend section 249 of the Immigration and Nationality Act to render available to certain long-term residents of the United States the benefit under that section.

**CAIR Position:** Support.

Status: Introduced in July 2022 and referred to the House Committee on the Judiciary.

**About:** This act updates an existing adjustment of status (green card application) process in the Immigration and Nationality Act (INA) using the discretionary registry provisions in Section 249. Specifically, the bill establishes a seven years of presence eligibility to apply for a green card. It incorporates a rolling component so that future legislation would not be required to update the INA registry. The "Renewing Immigration Provisions of the Immigration Act of 1929" would update the registry by replacing a specific cut-off date, currently January 1, 1972, with a minimum years of presence, the bill proposes seven years. The seven-year presence ensures that registry does not become obsolete over time.

The Registry process was first established in 1929 under the Registry Act of 1929, and the cut-off date was last updated (to 1972) in 1986 under then President Ronald Reagan as part of the Immigration Reform and Control Act (IRCA).

### **End Racial and Religious Profiling Act (ERRPA)**

**S.597:** To eliminate racial, religious, and other discriminatory profiling by law enforcement, and for other purposes.

Status: Introduced in the U.S. Senate and referred to the Senate Committee on Judiciary.

**CAIR Position:** Support

**About:** Introduced by Senator Ben Cardin (D-MD), the act prohibits racial and religious profiling by a federal, state, local, or tribal law enforcement agency or agent. The acts empower the Department of Justice (DOJ), or an individual injured by racial profiling, to bring a civil action to enforce the prohibition. They require federal law enforcement agencies to maintain policies and procedures to eliminate racial profiling, including training on racial profiling issues, the collection of data, and procedures for handling complaints.

Among its many statutory requirements, state or local governments that receive certain federal funds must maintain policies and procedures to eliminate racial profiling, including training on racial profiling issues, the collection of data, and participation in an administrative complaint procedure or independent audit program. The DOJ must withhold or reduce grant funds from a state or unit of local government that fails to comply.

## U.S. House Letter to the Appropriations Subcommittee on Homeland Security Requesting CP3 Reporting Language for Fiscal Year 2023

**CAIR Position:** Support.

**About:** Led by Representative Rashida Tlaib (D-MI) and addressed to the U.S. House Appropriations Subcommittee on Homeland Security, this letter urges the Department of Homeland Security to employ greater reporting measures to ensure transparency in their Countering Violent Extremism (CVE) legacy program Center for Prevention Programs and Partnerships (CP3).

The letter calls for third party accounting and oversight of the CP3 program and greater details on how the program ensures civil rights and liberties are being safeguarded in its administration.

**Note:** In the past two years, DHS has built up CP3 by seeking to increase federal grant funding for "communities across the United States to prevent individuals from radicalizing to violence and intervene when individuals have already radicalized to violence." Despite DHS acknowledging past mistakes were made with CVE and expressing a commitment to better "consider and respect civil rights and civil liberties," CAIR remains concerned about the program, and its lack of clarity in how it safeguards against possible civil rights violations. CAIR encourages community members not to apply for CP3 or related TVTP grants.

# Congressional Letters of Inquiry on Israel's Assassination of Shireen Abu Abkleh

U.S. House of Representatives' Letter Urging U.S. Investigation into Israel's Assassination of Shireen Abu Akleh (May 2022)

**CAIR Position:** Support

**About:** Led by U.S. Representative Andre Carson (D-IL) and signed by 56 other House Democrats, this letter addressed to the Federal Bureau of Investigation as well as the State Department requests that the U.S. government launch an investigation of the assassination of journalist Shireen Abu Akleh. This letter additionally requests the State Department to investigate whether any U.S laws protecting Abu Akleh's rights as a United States citizen were violated.

U.S. Senate Letter Urging U.S. Investigation into Israel's Assassination of Shireen Abu Akleh (June 2022)

**CAIR Position:** Support.

About: Led by U.S. Senator Chris Van Hollen (D-MD) and signed by 23 of his Senate colleagues, the letter directly called upon President Biden for a thorough, impartial investigation of the assassination of Shireen Abu Akleh and to hold her killers responsible. The letter additionally calls to hold those accountable for the ensuing chaos that took place during the funeral procession of Ms. Abu Akleh, as Israeli police attacked mourners by beating them, including the pallbearers, and causing the momentary dropping of one end of her casket.

#### **U.S. SENATE NOMINATIONS SUPPORTED BY CAIR**

President Biden's nominated Rashad Hussain, of Virginia, to be Ambassador at large for International Religious Freedom, Vice Samuel Dale Brownback.

**CAIR Position:** Support.

**Status:** Rashad Hussain was confirmed by the Senate in December 2021 by a vote of 85-5.

President Biden nominated Ketanji Brown Jackson, of the District of Columbia, to be an Associate Justice of the Supreme Court of the United States, vice Stephen G. Breyer, retiring.

**CAIR Position:** Support.

**Status:** Ketanji Brown Jackson was confirmed by the Senate in April 2022, by a vote 53-47.
